

**INNOVATION VOICE TECHNOLOGIES, INC.
END USER AGREEMENT**

PLEASE READ THIS END USER LICENSE AGREEMENT ("AGREEMENT") CAREFULLY. BY INSTALLING AND/OR USING INNOVATION VOICE TECHNOLOGIES, INC. ("INNOVATION") PRODUCTS AND SOFTWARE YOU (THE "LICENSEE") ARE AGREEING TO BE BOUND BY THE TERMS OF THIS AGREEMENT. YOUR USE OF THE SOFTWARE MAY BE SUBJECT TO ADDITIONAL SOFTWARE LICENSES AND/OR PROFESSIONAL SERVICES AGREEMENTS, WHICH MAY CONTAIN ADDITIONAL TERMS AND CONDITIONS. ALL QUESTIONS REGARDING INSTALLATION AND USE OF INNOVATION PRODUCTS SHOULD BE DIRECT TO techhelp@innovationtw.com

1. Software. Innovation is the owner and/or licensee of the Innovation software and associated documentation (the "Documentation"), including without limitation to the object code, proprietary algorithms, methods, concepts, logic and program architecture embodied in the software (collectively referred to as the "Software").

2. License. Innovation grants Licensee a limited, nonexclusive, nontransferable license to use the Software on a single computer for Licensee's internal use during the term of this Agreement. Licensee shall not use or permit the use of the Software for the processing of data for any person or entity other than Licensee. Licensee shall comply with all provisions of any applicable laws, regulations, rules and orders relating to the license herein granted and to the use of the Software. Licensee shall not export or re-export the Software from the United States ("U.S.") without the prior written approval of Innovation and then only in compliance with all applicable laws and export administration regulations of the United States Government.

3. Scope of Use. Licensee shall not modify or create derivative works based upon the Software. Licensee shall not disassemble, decompile, reverse engineer or translate the Software, nor shall Licensee encourage or knowingly allow others to do so. Licensee shall not sell, rent, lease, license, sublicense, display, modify, time share, outsource or otherwise transfer the Software to any third party. Licensee has no right to receive or possess any Software source code, but shall receive only machine-readable object code under this Agreement. Any Software source code obtained, in whatever manner, by Licensee shall be subject to the terms and conditions of this Agreement as part of the Software. Licensee may make up to two copies of the Software for back-up and archival purposes only. Any such copies shall contain the same proprietary notices and legends that appear on the Software supplied by Innovation. Licensee agrees that it will not use, or knowingly allow others to use, the Software or any related data for the purpose of creating computer software which is competitive with the Software, and it will not furnish any information, data or copies of the Documentation to any third party to assist in the creation or design of competitive computer software. Licensee agrees to comply with any nondisclosure or licensing provisions contained in agreements or manuals pertaining to the Third-Party Software and provided by Innovation. The obligations of Licensee under this section 4 shall survive termination of this Agreement. Notwithstanding the above, provided Licensee is not in breach of this Agreement, Licensee may sell the hardware along with the Software

installed on the hardware as a single unit to a third party. Such third party's rights to use the hardware and Software shall be subject to this Agreement, without modification. Under no circumstances shall Licensee or a subsequent purchaser use the Software apart from the hardware or on any other hardware other than the original hardware provided by Innovation.

4. Software Ownership. The Software is proprietary to Innovation or its licensors and all title and interest thereto shall remain with Innovation or its licensors respectively. Innovation and its licensors reserve all rights not expressly granted to Licensee. Licensee shall not challenge Innovation's or its licensor's ownership of the Software, and shall not assist or cooperate with any third party bringing such a challenge. Innovation retains the right to modify the Software at any time without prior notice to Licensee.

5. Term and Termination. The term of this Agreement shall be perpetual unless terminated in accordance with the terms herein. Innovation may terminate this Agreement immediately, and without prior notice or demand upon (a): Licensee's breach of any term of this agreement, or (b) upon Licensee's failure to make any payment owed to Innovation by its due date. Licensee may terminate this Agreement at any time by written notice to Innovation. Upon termination, Licensee's right and license to use the Software shall immediately cease and Licensee shall uninstall and destroy all copies of the Software and delete all copies of the Software from Licensee's computers and data storage devices. Licensee shall not be entitled to the return of any fees paid under this Agreement. The provisions of sections 3, 4, 6, 8, 10 and 11 shall survive the termination of this Agreement.

6. Software and Hardware Warranties. Innovation represents and warrants that the Innovation software delivered with the System will operate in accordance with the Documentation for a period of six (6) months from the date of purchase. Licensee may purchase additional technical support and software warranty protection (the "Technical Support and Software Assurance Program") under a separate Technical Support and Software Assurance Program Agreement as further described in Section 7 below. Innovation represents and warrants that the InnLine Express hardware will be free from material defects for a period of one (1) year from the date of purchase and all other messaging products will be free from material defects for a period of two (2) years from the date of purchase.

7. Technical Support and Software Assurance Program. Provided Licensee is in compliance with this Agreement, Licensee may purchase additional hardware and software support services from Innovation's authorized distributors under the Technical Support and Software Assurance Program ("Support Services"). The terms and conditions of Support Services are set forth in the Technical Support and Software Assurance Program Agreement located at www.innovationtw.com/support/agreements. Support Services shall commence on the date upon which Licensee pays Innovation's distributor the then current annual Support Services fees. Support Services shall not be transferable to any third party without the express written permission of Innovation.

8. WARRANTY DISCLAIMER; LIMITATION ON INNOVATION'S LIABILITY. OTHER THAN THE WARRANTIES SET FORTH IN SECTION 6 ABOVE, , AND ANY

OTHER THIRD PARTY MANUFACTURER WARRANTY (if any), NO OTHER WARRANTIES ARE PROVIDED FOR THE SOFTWARE AND HARDWARE. INNOVATION SHALL NOT HAVE ANY LIABILITY, OR HAVE ANY OBLIGATION TO PROVIDE WARRANTY COVERAGE, FOR ANY THIRD PARTY HARDWARE OR SOFTWARE. INNOVATION MAKES NO REPRESENTATIONS OR WARRANTIES OF ANY KIND WITH RESPECT TO THE INSTALLATION, USE OR PERFORMANCE OF THE SOFTWARE. INNOVATION HEREBY DISCLAIMS ALL WARRANTIES, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, AND ASSUMES NO RESPONSIBILITIES WHATEVER WITH RESPECT TO LICENSEE'S INSTALLATION AND USE OF THE SOFTWARE OR THE PERFORMANCE OF THE SOFTWARE. IN NO EVENT SHALL INNOVATION, INCLUDING ITS RESPECTIVE DIRECTORS, OFFICERS, EMPLOYEES AND AGENTS, BE RESPONSIBLE OR LIABLE TO LICENSEE OR ANY OTHER THIRD PARTY FOR ANY DIRECT, INDIRECT, SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES OR LOST PROFITS OR OTHER ECONOMIC LOSS OR DAMAGE WITH RESPECT TO THE SOFTWARE REGARDLESS OF LEGAL THEORY. THE ABOVE LIMITATIONS ON LIABILITY APPLY EVEN THOUGH INNOVATION OR SUCH THIRD-PARTY LICENSOR OR ANY OF THEIR RESPECTIVE DIRECTORS, OFFICERS, EMPLOYEES OR AGENTS MAY HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGE.

9. Injunctive Relief. Licensee acknowledges and agrees that monetary damages alone would be an inadequate remedy in the event of a breach by Licensee of its obligations under this Agreement. Innovation and/or its licensors shall be entitled to obtain injunctive relief to require Licensee to comply with such obligations. Such remedy shall be cumulative and not exclusive.

10. Assignment. Licensee shall not assign this Agreement, the Software license granted to Licensee, or any of Licensee's other rights or obligations hereunder without the prior written consent of Innovation. Licensee shall not sell, rent, lease, loan, sublicense or otherwise transfer the Software or Software license granted in this Agreement.

11. Miscellaneous. The parties acknowledge that Innovation shall perform its obligations under this Agreement as an independent contractor. This Agreement shall not create a joint venture, partnership or principal and agent relationship between the parties. This Agreement may not be modified, amended or supplemented except by mutual written agreement of Innovation and Licensee. Either party may waive in writing any term or condition contained in this Agreement and intended to be for its benefit; provided, however, that no waiver by a party, whether by conduct or otherwise, in any one or more instances, shall be deemed or construed as a further or continuing waiver of any such term or condition. This Agreement represents the entire agreement of the parties with respect to the subject matter hereof and no provision or document of any kind shall be included in or form a part of this Agreement except by mutual, written consent of Innovation and Licensee. The provisions contained in this Agreement are severable. If any provision of this Agreement is determined for any reason to be invalid, illegal or unenforceable, such determination shall not affect the validity, legality or enforceability of the remaining provisions, and the rights and obligations of the parties shall be construed and

enforced as though this Agreement did not contain such invalid, illegal or unenforceable provision. This Agreement shall be governed by and construed in accordance with the internal laws of the State of Wisconsin and the Federal laws of the United States without reference to any rule or provision thereof which would cause the application of the law of any other jurisdiction. Section headings are solely for the convenience of the reader and are not intended for interpretation or construction of this Agreement.
